# RUSH Physician Group leaves BCBS HMOs

On October 29, 2010 we were informed by BCBS of Illinois that they were unable to reach an agreement with the Rush Physician Group – Rush Health Associates for the 2011 plan year. As a result, this physician group will be removed from all BCBS HMO networks effective January 1, 2011.

If you are an HMO member that is currently using Rush, you should contact your primary care physician (PCP) and determine if he/she is part of any other physician group within the BCBS HMO network (besides Rush Health Associates). If you need to change your physician for the 2011 plan year, please contact BCBS at 800-892-2803.

Your CVS Caremark iBenefit Report is a personalized summary of your prescription history. It highlights opportunities to save you money. Based on your history, the report will show how you can save by using generics, preferred brands, and 90-day service. It also measures the savings that could be realized if you make a change.

While overall utilization of medications is up by 3%, member cost is down by 14%.

70% of all prescriptions filled are now generic – an increase of 5% in the last 9 months.

4 of the top 5 therapeutic categories are lifestyle related; Ulcers, Blood Pressure, Cholesterol and Type 2 Diabetes - these 4 categories account for 37% of our prescription plan cost.

We kicked off a Diabetes Management Program in January 2010 to assist the 25% of our members identified with Type 2 Diabetes. To date, 85% of those contacted are participating in the program.

# Health Care Reform

### WHAT DOES THIS MEAN FOR THE FUND'S RETIREE HEALTH BENEFIT?

The Fund offers a retiree-only insurance plan, which makes us exempt from the Health Care Reform requirements at this time. However, the Fund has been proactively adhering to



the standards of this law, including allowing dependant coverage to age 26 and eliminating lifetime maximums. We will continue to efficiently monitor and manage the Retiree Health Benefit on behalf of our members as we strive to ensure the highest quality of benefits for all.

### Vaccination Station

- If you smoke, you should quit
- Stay home if you have a cough or fever
- Sneeze or cough into a tissue or the crook of your arm, not your hands
